- 1: 7:05 **Meeting called to order** by Chairman Michael Bossin.

## 3: 7:10 **Correspondences**

- 1. Walter Newman's letter was approved by the Board of Selectman and sent via email to all Town Hall committees and departments.
  - Barbara Kramer requested Gary Bluestein read Walter's letter to the group.
- 2. Letter received from Anne Bingham noting the fact that the minutes were not posted on the Town of Sharon website.
  - Duly noted that all minutes going forward will be posted to the Town of Sharon website.
- 3. Letter received from Eli Hauser commending the committee on working to utilizing the Horizon for Youth property with suggested recommendations for consideration:
  - Revenue
  - Building Fund
  - New Buildings
  - Lake Facilities

- 4. Andy asked if the minutes of each Horizon for Youth Reuse Committee meeting be filed with the Town Clerk.
  - Gary Bluestein to check with Marleen Chused if this is required.

#### 4: 7:15 Improper Elections

The committee was notified by the Town Administrator Ben Puritz that Town Counsel sent him a note that the secret ballot that was taken at the June 18, 2007 meeting is not recognized as an official voting procedure under the State of Massachusetts Open meeting Law and the need to do a new election with an open vote for the three positions be taken.

After a short discussion on whether we should wait for the whole Committee it was agreed to take a vote as the chances of ever having the whole Committee at one meeting was slim.

- 1. Jane Desberg nominated Michael Bossin for Chairman for a 1-year term. Barbara Kramer seconded. 8 votes for Mike with one abstention Marc Bluestein
- 2. Jane Desberg nominated Andy Nebenzal for Vice Chairman for a 1-year term. Jay Bronstein seconded the nomination. The vote was unanimous
- 3. Jane Desberg nominated Gary Bluestein for Central Recording Secretary/Communications Correspondent for a 1-year term. Barbara Kramer seconded the nomination. The vote was unanimous.

#### 5: 7:25 Continuation of Brainstorming session

- 1. Walter Newman's letter approved, accepted with no changes.
- 2. Number one concern is the fact that we need to evaluate interested parties.
- 3. Copies of Gerry Sapphire's proposal /questionnaire form to be used as a basic format were passed to each committee member for discussion as to what additions or comments need to be added or deleted.

All agreed that the proposal should first start with an introductory paragraph. With that in mind, the question proposed whether the form should be written with check-off boxes and a comment line to follow each topic or a required a written paragraph under each topic to include:

- Type of organization (non-profit, fraternal, etc.)
- Financial impact to the Town plus or minus
- Background references
- Accreditations
- Biography or history of organization
- References
- Capital improvements
- Facilities being used
- What benefits to the Town
- Time duration (yearly, monthly, and hours)
- Exclusive or shared use of property

- Impact (environmental, traffic, resources)

Diane Pankow will put together a form to include all of the above topics with a target date to submit at the next meeting of August 27th.
